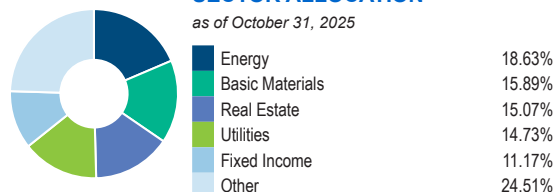
ASSET ALLOCATION

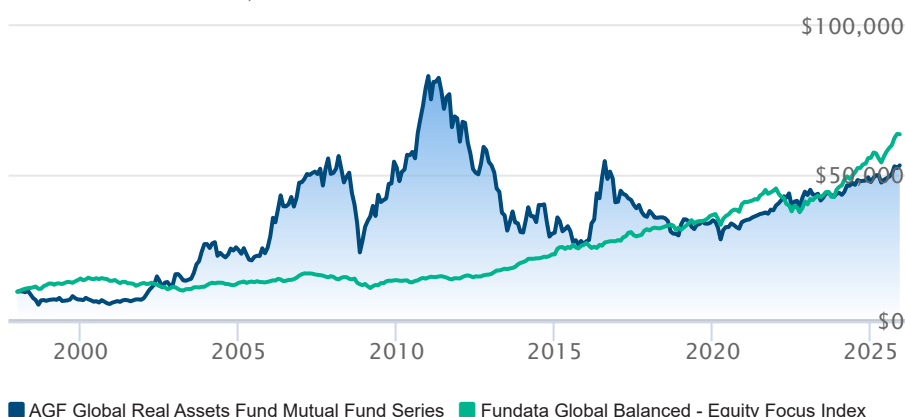
