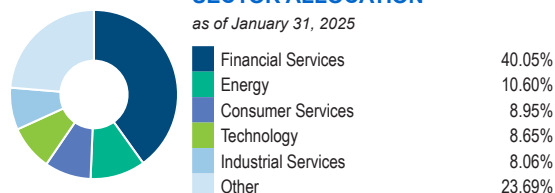
ASSET ALLOCATION
