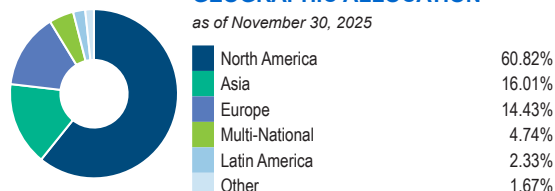
SECTOR ALLOCATION

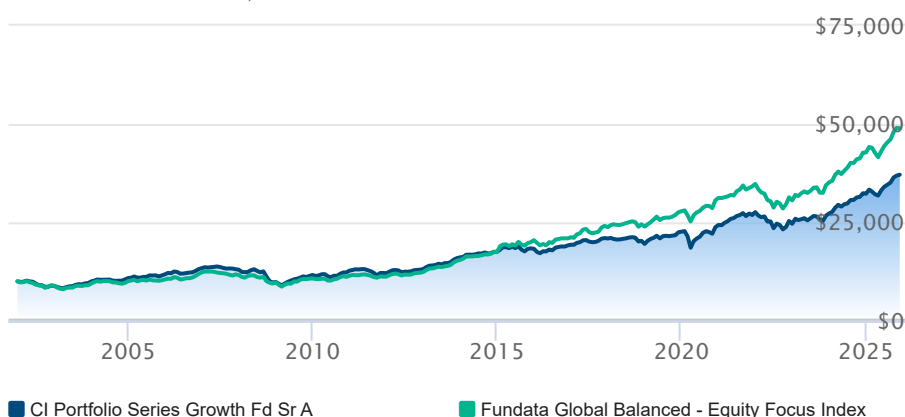
