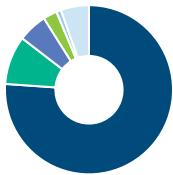

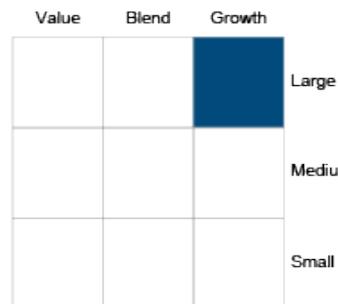
GEOGRAPHIC ALLOCATION

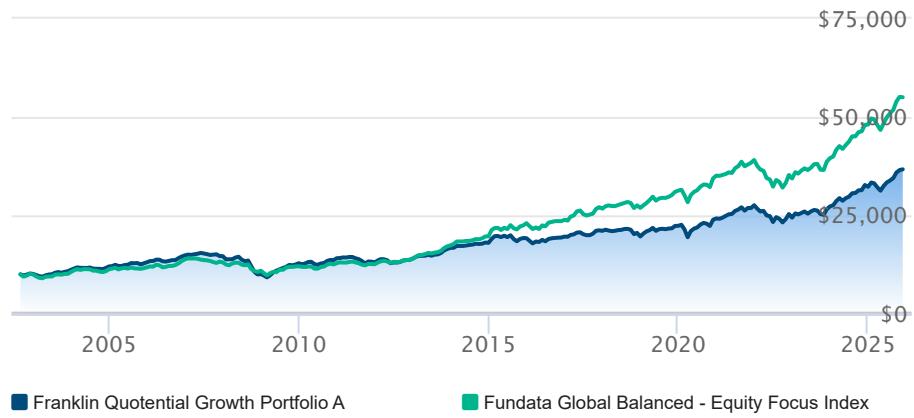
