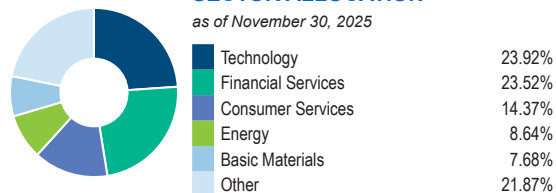
## ASSET ALLOCATION

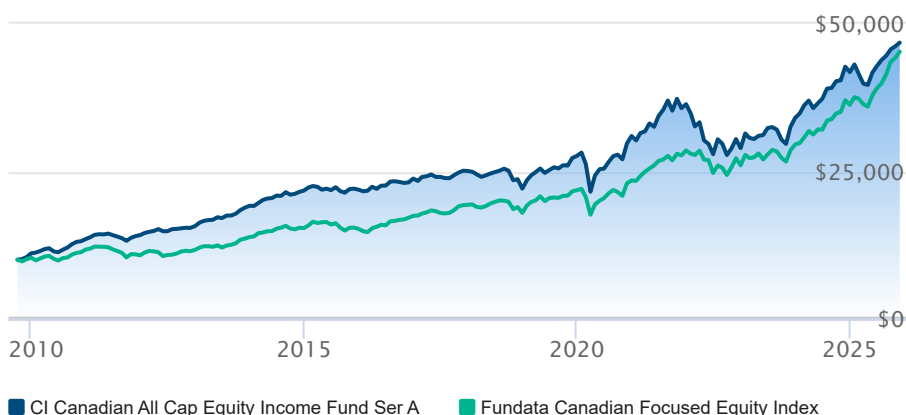
