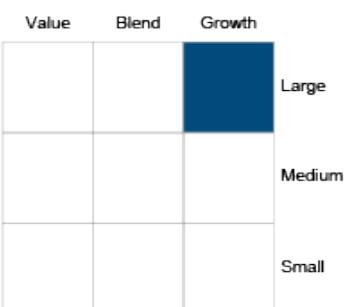


GEOGRAPHIC ALLOCATION


