as of September 30, 2025

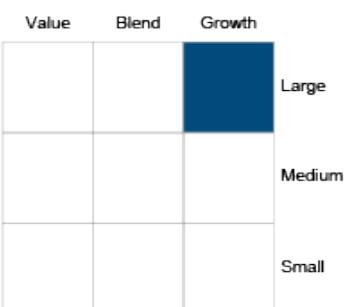


GEOGRAPHIC ALLOCATION

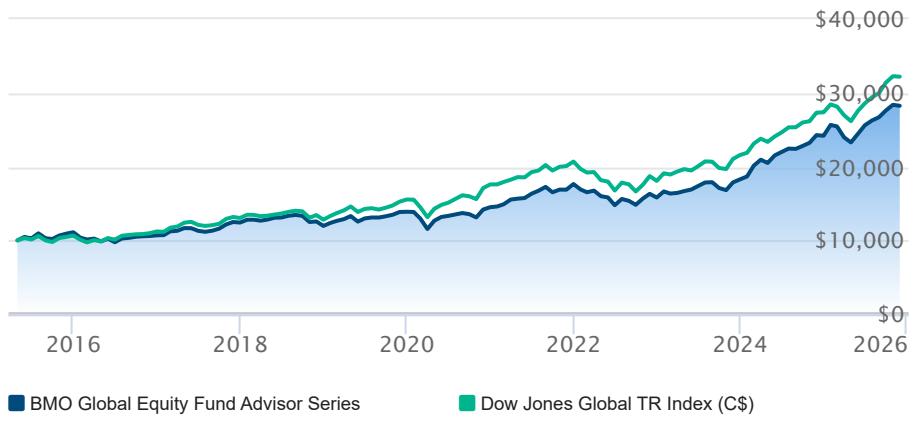
