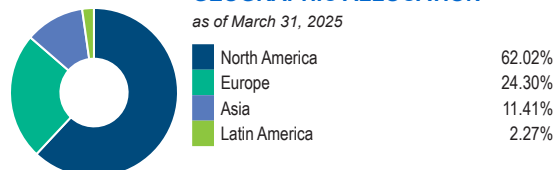
## SECTOR ALLOCATION

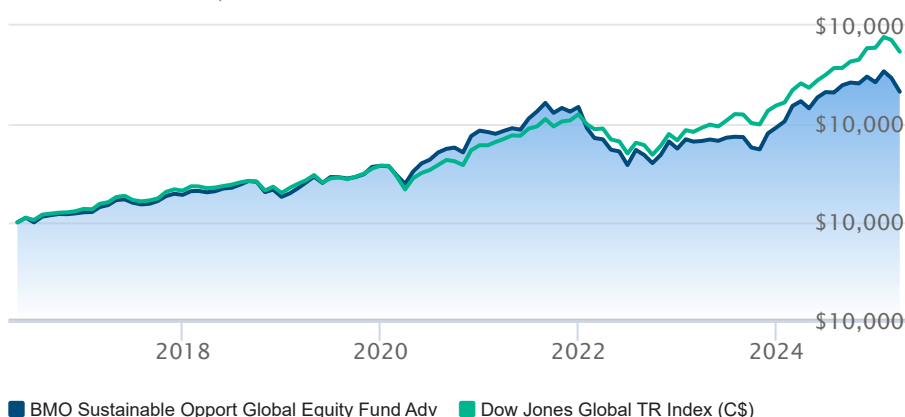
